In contemporary philosophy, substantive moral theories are typically classified as either consequentialist or deontological. Standard consequentialist theories insist, roughly, that agents must always act so as to produce the best available outcomes overall. Standard deontological theories, by contrast, maintain that there are some circumstances where one is permitted but not required to produce the best overall results, and still other circumstances in which one is positively forbidden to do so. Classical utilitarianism is the most familiar consequentialist view, but it is widely regarded as an inadequate account of morality. Egypt has changed enormously in the last half century, and nowhere more so than in the villages of the Nile Valley. Electrification, radio, and television have brought the larger world into the houses. Government schools have increased educational horizons for the children. Opportunities to work in other areas of the Arab world have been extended to peasants as well as to young artisans from the towns. Urbanization has brought many families to live in the belts of substandard housing around the major cities. But the conservative and traditional world of unremitting labor that characterizes the lives of the Egyptian peasants, or fellaheen, also survives, and nowhere has it been better described than in this classic account by Father Henri Habib Ayrout, an Egyptian Jesuit sociologist who dedicated most of his life to creating a network of free schools for rural children at a time when there were very few.
